Once your application has been verified as meeting the requirements for admittance to the examination you will be **emailed** the Training and Experience Examination link. Please be sure to include your current email address on your application.

# **POSITION DESCRIPTION**

The Staff Program Auditor (IS) is the super journey level requiring incumbents, with minimal direction, independently and proficiently to handle highly complex, visible, and/or sensitive internal and field information systems audits, evaluations, reviews, and consulting assignments, and to present findings to management. Incumbents have developed highly specialized information systems review skills and have demonstrated strong analytical abilities and a comprehensive understanding of a broad range of financial and management issues. Incumbents may also assist in the CalPERS' risk assessment and biennial audit planning processes; assist with audit and program evaluation report quality reviews; provide specialized assistance and training in complex information systems auditing and review techniques to other evaluator staff; and may function in a lead capacity with other evaluators.

# **MINIMUM QUALIFICATIONS**

All applicants must meet the education and/or experience requirements as stated on this examination announcement.

#### Either I

**Experience:** One year of experience in the California state service performing professional information systems auditing duties of a class at a level of responsibility at least equivalent to an Associate Program Auditor (IS), CalPERS.

#### Or II

Experience: Four years of increasingly responsible experience performing professional auditing, including at least three years' experience in information systems auditing and programming systems analysis of large or complex data processing systems. Experience must have included the preparation of written audit reports and the presentation of recommendations to management. For at least one year, these responsibilities must have included duties at a level equivalent to an Associate Program Auditor (IS), CalPERS. Possession of an advanced degree (master's or doctorate degree) in one of the subjects described in the education requirement may be substituted for the required experience on

the basis of a master's degree being equivalent to one year of experience and a doctorate degree equivalent to two years of experience. **And** 

**Education:** A four-year college degree, preferably with a major in accounting, business administration, public administration, economics, mathematics, management information systems, computer sciences, computer programming, or a related field. (*Registration as a senior in a recognized institution will admit applicants to the examination, but they must produce evidence of graduation or its equivalent before they can be considered eligible for appointment.)* 

**NOTE:** Your application will be rejected if you do not provide a copy of the required educational document transcript/degree which shows the completed college requirement at the time of filing the application.

**NOTE:** Your signature on your application indicates that you have read, understood, and possess the basic qualifications required.

# **DEFINITION OF TERMS IN MINIMUM QUALIFICATIONS**

The words "duties of a class with a level of responsibility" means that the applicant must have State civil service experience of appropriate type and length in a class at the same or higher level of responsibility as the class specified.

The words "performing the duties of" means that the applicant must have the amount of experience in State civil service in the class specified (or on a training and development (T&D) or approved out-of-class assignment to the class.

"Equivalent to graduation from college" is defined as: Satisfaction of the requirements for a bachelor's degree from an accredited college. This means the applicant must show receipt of a bachelor's degree (4-year college)

#### **EXAMINATION SCOPE**

Training and Experience Evaluation – Weighted 100% of the final score.

The examination will consist solely of a **Training and Experience Evaluation.** To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

# **Knowledge of:**

- 1. Principles and practices of business and organizational management.
- 2. General accounting and auditing principles and procedures.
- Quantitative and cost effectiveness analysis methods.
- 4. Principles of information systems.
- 5. Professional information systems auditing, security, and control standards and practices.
- 6. Professional internal auditing standards and practices.

#### Ability to:

- 1. Apply the required knowledge.
- 2. Identify, analyze, and recommend effective solutions to complex information

- systems control problems.
- 3. Learn and apply specialized information systems auditing methods and procedures.
- 4. Conduct complex information systems audits and evaluations of policies, programs, systems, and procedures, and those entities doing business with the department.
- 5. Clearly define objectives and develop approaches and methodologies to meet those objectives.
- 6. Identify controversial or sensitive issues affecting assignments.
- 7. Conduct effective interviews with staff at all levels.
- 8. Conclude as to the adequacy, completeness, accuracy, and fairness of data.
- Prepare clear, complete, and concise work papers and reports to effectively communicate results of work.
- 10. Reason logically and creatively and use a variety of analytical techniques to evaluate and resolve problems.
- 11. Make decisions and take appropriate action.
- 12. Communicate effectively.
- 13. Act as a team leader.
- 14. Provide advice and instruction to staff on methods of performing complex information systems audits or computer assisted testing techniques.
- 15. Gain and maintain the confidence and cooperation of those contacted during the course of work.
- 16. Develop and evaluate alternatives to resolve problems identified.

## SPECIAL PERSONAL CHARACTERISTICS

Willingness to travel and work away from the headquarters office and work long and irregular hours; demonstrated ability to act independently; open-mindedness; flexibility; tact; willingness to pursue a course of continuing professional education as prescribed by the Standards for the Professional Practice of Internal Auditing and the Standards for Information Systems Auditing.

# **ELIGIBLE LIST INFORMATION**

The eligible list for the STAFF PROGRAM AUDITOR (IS) classification will be established for California Public Employees' Retirement System (CalPERS):

The names of **successful** competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **12 months** after the list established date. Applicants must then retake the examination to reestablish eligibility. **CalPERS vacant positions are located are in Sacramento.** 

**NOTE:** The eligibility list can be used to fill vacancies statewide with other departments.

## **VETERANS' PREFERENCE**

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Veterans' status is verified by the California Department of Human Resources (CalHR). Information on this program and <u>Veterans' Preference Application</u> (Std. form 1093) is available <u>online</u>. Additional information on veteran benefits is available at the Department of Veterans Affairs.

# **CAREER CREDIT**

Career Credits will not be granted in this examination.

## **EXAMINATION INFORMATION**

#### TRAINING AND EXPERIENCE EXAMINATION WEIGHTED 100.00%

The entire examination will consist of an evaluation of training and experience weighted 100%. The Training and Experience Examination is designed to elicit specific information regarding each candidate's Knowledge, Skills and Abilities relative to the testing classification. Responses to the examination will be assessed based on pre-determined rating criteria. All applicants must complete the entire examination to receive a score. The examination process takes approximately one hour to complete. All competitors will be ranked competitively based on the responses. In order to obtain a position on the eligible list, you must meet the examination requirements and must attain a minimum score of 70% on the examination.

**NOTE:** Be sure to include your current email address on your application. If you do not include your email address you will not receive the link to take the examination.

**Employment History:** Employment dates, job titles, organization names and addresses, names of supervisors or persons who can verify your job responsibilities, and phone numbers of persons listed above.

**Education:** School names and addresses, degrees earned, dates attended, courses taken (verifiable on a transcript), persons or office who can verify education, and phone numbers of persons or offices listed above.

**Training:** Class titles, certifications received, names of persons who can verify your training, and phone numbers of persons listed above.

## **GENERAL INFORMATION**

Examination and/or Employment Application (STD 678) forms are available at the California Department of Human Resources, local offices of the Employment Development Department, and through your <u>CalCareers Account.</u>

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The California Public Employees' Retirement System (CalPERS) reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

**Criminal Record Clearance Information:** Upon employment, California Public Employees' Retirement System positions are subject to fingerprinting and a criminal record check requirement. This check will be completed by the Department of Justice. Applicants will be notified during the hiring process if the position is affected by the criminal record clearance procedure. The criminal record clearance is a condition of employment in positions affected by this procedure.

**General Qualifications:** Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

**Eligible Lists:** Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be

used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.
