## MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

#### **Project Director 1**

Equivalent to graduation from college with major work in architecture, engineering, construction management, or closely related field. (Additional qualifying experience may

be substituted for the required education with two years of experience being counted as one year of the required education.) **And** 

#### Either 1

Two years of experience in California state service in the class Architectural Project Production Analyst.

#### Or 2

One year of experience in the class Associate Estimator of Building Construction, Associate Construction Analyst, or Architectural Associate.

#### Or 3

Three years of varied experience in architecture, engineering or construction management at least 50% of which shall have been in the planning, estimating or administration of projects resulting in a building or structure being constructed.

## **POSITION DESCRIPTION**

#### **Project Director 1**

This is the entry level into the series. In this class, incumbents, under close supervision, provide oversight and management of the less complex and less sensitive capital outlay projects. Types of projects assigned to Project Directors 1 would be smaller Employment Development Department, Department of Motor Vehicles, and California Highway Patrol field offices, and installation of smaller water treatment and sewage systems. It also includes new or replacement construction of smaller warehouses, single-story office structures, smaller parks and recreation projects, and individual support facilities at the various types of institutions. The common denominator for these types of projects is that they tend to be new construction and types of facilities which have been constructed many times previously.

## **EXAMINATION SCOPE**

This examination consists of the following components:

Training and Experience Evaluation – Weighted 100% of the final score.

The examination consists solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process. In addition to evaluating applicants' relative knowledge and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

#### Knowledge of:

- 1. All phases of the State's capital outlay process
- 2. Architecture
- 3. Details of planning, designing and constructing public buildings
- 4. Architectural building materials
- 5. Costs, codes and construction methods
- 6. Structural, electrical and mechanical engineering as related to buildings

- 7. Principles of budgeting as related to the capital outlay process
- 8. Use and application of computers in capital outlay project monitoring

#### Ability to:

- 1. Analyze comprehensive architectural designs
- 2. Present information clearly and effectively in pictorial and written forms
- 3. Analyze situations accurately and adopt an effective course of action

#### **ELIGIBLE LIST INFORMATION**

A departmental, open eligible list for the **Project Director 1** classification will be established for:

#### Department of General Services Department of Corrections and Rehabilitation

The names of **successful** competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Veterans status is verified by the California Department of Human Resources (CalHR). Information on this program and <u>the Veterans' Preference Application</u> (Std. form 1093) is available online. Additional information on veteran benefits is available at the Department of Veterans Affairs.

Career Credits **will not** be added to the final score of competitors who are successful in this examination.

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The Departments of General Services and the Corrections and Rehabilitation reserve the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

High School Equivalence: Equivalence to completion of the 12<sup>th</sup> grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
