ELIGIBLE LIST INFORMATION

An open, merged eligible list will be established by the California Department of Human Resources for use by the California Department of State Lottery. The names of successful competitors will be merged onto the eligible list in order of final score regardless of test date. Eligibility expires 12 months after it is established. Competitors must then retake the Training and Experience Evaluation to reestablish eligibility.

REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION

MINIMUM QUALIFICATIONS

Lottery Ticket Sales Specialist

All levels:

Lottery Ticket Sales Specialist:

Two years of [wholesale sales](#) experience, one year of which must have been in [inventory management](#). (Experience in the California state service applied toward this requirement must include one year in a class with a level of responsibility not less than that of an [Office Assistant, Range B.](#))

Lottery Ticket Sales Senior Specialist

Either I:

One year of experience in the California state service performing duties comparable to those of a [Lottery Ticket Sales Specialist](#).

OR II

Three years of [wholesale sales](#) experience, one year of which must have been in [inventory management](#). (Experience in the California state service applied toward this requirement must include one year performing duties comparable to those of a [Lottery Ticket Sales Specialist](#).)



Definition of Terms:

Wholesale Sales- For recruitment purposes, wholesale is defined as selling a product or services to a business (business to business sales).

Establishing and Servicing Accounts - Persons who may be considered as having experience in establishing and servicing wholesale accounts are both those who sell wholesale to retail establishments or small businesses.

Examples of Accepted Experience:

Generally accepted experience includes, but is not limited to, professional sales experience acquired through such industries as: medical equipment sales, pharmaceutical sales, insurance brokerages, banking and other business-to-business sales activities.

POSITION DESCRIPTION

Definition of Levels

Lottery Ticket Sales Specialist

This is the entry, training, and journey level for this series. Under general supervision, develop the scratcher ticket orders for individual retailers which include a mix of games in order to meet established sales projections for a varied group of retail locations. Work is subject to occasional review and may require incumbents to resolve sensitive retailer complaints and/or problems.

Lottery Ticket Sales Senior Specialist

This is the advanced journey level for this series. Under general supervision, incumbents function as staff specialists for an assigned group of retail locations to resolve the most difficult, complex, and sensitive scratcher ticket inventory issues; assist in training; and provide lead to lower-level Lottery Ticket Sales Specialists. Work is subject to occasional review.

EXAMINATION INFORMATION

TRAINING AND EXPERIENCE EVALUATION – Weighted 100%

The examination will consist solely of a Training and Experience Evaluation. To obtain a position on the eligible list, a minimum score of 70% must be received. An applicant will receive his/her score upon completion of the Training and Experience Evaluation process.

KNOWLEDGE AND ABILITIES



Lottery Ticket Sales Specialist and Lottery Ticket Sales Senior Specialist:

Knowledge of:

1. Inventory management techniques to ensure proper rotation of a product and ensure inventory is sufficient.
2. The differences and needs of various retail establishments (e.g., chain stores, independent/corporate) to assist in maximizing sales.
3. The internet and/or intranet to conduct online research and obtain information related to programs and projects.
4. Research and data gathering techniques (e.g., online resources, search engines, data bases) to compile information for projects and assignments.
5. Basic record keeping techniques and order tracking information to provide information to retailers.
6. Basic mathematics (e.g. addition, subtraction, percentages, multiplication division) to complete assignments.
7. The structure and content of the English language including the meaning and spelling of words, rules of composition and grammar.

Ability to:

1. Interpret and apply sales and inventory data to create replenishment orders and maximize sales.
2. Create and develop customized retail orders for varying demographics to maximize sales.
3. Conduct statistical analyses of reports to recommend appropriate mix of games and products to retailers.
4. Identify required data needed to perform tasks, address issues, evaluate program effectiveness, and/or serve as a basis for program/project-specific decisions.
5. Use logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions or approaches to problems.
6. Interpret and analyze statistical reports to verify the efficiency of work processes for retailers and staff.
7. Read and comprehend written material to remain current with regulations and maximize sales.
8. Deal with challenging customers and retailers and still provide satisfactory service in a professional manner.
9. Establish and maintain constructive relationships with external contractors and internal support staff.
10. Verbally communicate information in a variety of settings (e.g. retail environments, local public groups) to maximize sales and enhance customer service.
11. Present research findings and results at the appropriate level of complexity given the intended audience.
12. Establish long-range objective and specify the strategies and actions to achieve them.
13. Establish, prioritize, coordinate, and implement work assignments to complete projects and assignments within established timeframes.
14. Be flexible and work in a rapidly changing environment.
15. Communicate information in writing (via email, memos, etc.) to different audiences using word processing software.



16. Work cooperatively with diverse individuals and cultures to maintain positive working relationships with involved parties.
17. Work as a team member, understanding how each member's efforts contribute to a department goal.

Lottery Ticket Sales Senior Specialist (Additional Abilities)

1. Promote and assist in the implementation of marketing strategies and techniques to maximize sales.
2. Delegate work assignments at the appropriate level of responsibility to staff.
3. Independently review and edit written materials.

VETERANS' PREFERENCE

Veterans' Preference will be granted for this examination. Effective January 1, 2014, in accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, widow or widower of a veteran, or spouse of a 100 percent-disabled veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligibility list. This section shall not apply to any veteran who has been dishonorably discharged or released.

GENERAL INFORMATION

If a candidate's notice of oral interview or performance test fails to reach him/her 3 days prior to their scheduled appointment due to a verified postal error, he/she will be rescheduled upon written request.

Examination Locations: When a written test is part of the examination, it will be given in such places in California as the number of candidates and conditions warrant. However, locations of interviews or performance evaluations may be limited or extended as conditions warrant.

Applications are available at www.jobs.ca.gov and local offices of the Employment Development Department.

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described on this bulletin will be rated against a predetermined job-related rating, and all candidates who pass will be ranked according to their scores.

The California Department of Human Resources reserves the right to revise the examination plan to better meet the needs of the service, should the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules, and all competitors will be notified.

Candidates needing special testing arrangements due to a disability must mark the appropriate box on the application and contact the testing department.

Hiring Interview Scope: In a hiring interview, in addition to the scope described in this bulletin, the panel will consider education, experience, personal development, personal traits, and fitness. In appraising experience, more weight may be given to the breadth and recency of pertinent experience, and evidence of the candidate's ability to accept and fulfill increasing responsibilities than to the length of his/her experience. Evaluation of a candidate's personal development will include consideration of his/her recognition of his/her own training needs; his/her plans for self-development; and the progress he/she has made in his/her efforts toward self-development. General Qualifications: Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history, and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in



the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, and 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

Veterans' Preference: Effective January 1, 2014, in accordance with Government Codes 18973.1 and 18973.5, Veterans' Preference will be awarded as follows: 1) Any veteran, widow or widower of a veteran, or spouse of a 100 percent disabled veteran, who achieves a passing score in an entrance examination, shall be ranked in the top rank of the resulting eligibility list. Any veteran who has been dishonorably discharged or released is not eligible for Veterans' Preference. 2) An entrance examination is defined, under the law, as any open competitive examination. And 3) Veterans' Preference is not granted once a person achieves permanent civil service status.

Veteran status is verified by the California Department of Human Resources (CalHR). Directions to apply for Veterans' Preference are on the Veterans' Preference Application (Std.
